19. Maintain first Aid Kits in sufficient numbers in the school premises.

Memo No. 21748/D1/97 Dt. 16-2-1998 and other orders of Transport Authority regarding parking of school Vehicles/maintenance of vehicles and ensure safety of children and shall obtain fitness of the school vehicles from the transport authorities as prescribed by the Government from time to time. 21. 19 The Edn. Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt from time to time by the end of April every year as per G.O.6th cited.

The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P. Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once

21 The Management shall provide sufficient transportation, sufficient fire extinguishers in the school. The management will be personally responsible to get update No Objection Certificate from the authorities concerned...
